SUBJECT MATTER OF THE CASE

The applications concern various types of interference with the applicants' right to freedom of expression, which can be divided into five groups.

Groups 1 and 2 concern the applicants' prosecution in administrative and criminal proceedings, respectively, for publicly sharing information or staging solo demonstrations, which the Russian authorities considered to be tarnishing the image of the Russian military or deviating from the official narrative of Russia's war against Ukraine.

Group 3 concerns an attack on journalists during a press tour to the Chechen Republic and the lack of an effective investigation.

Group 4 concerns the Russian authorities' refusal to provide access to archival documents about the victims of political repression in the Soviet Union.

Group 5 concerns complaints by major Internet platforms, including Twitter, Google, and Meta, about excessive fines imposed on them for failure to remove information which was considered damaging to the reputation of the Russian authorities.

QUESTIONS TO THE PARTIES

Groups 1 and 2: Has there been a violation of Article 10 of the Convention on account of the applicants' prosecution for their expressive conduct?

Group 3: Has there been a violation of Articles 3, 8, 10 of the Convention or Article 1 of Protocol No. 1, taken on their own or in conjunction with Article 13, relating to the attack on the applicants who were carrying out their journalistic work, the absence of an effective investigation into the attack, the theft of their personal items and professional equipment, the burning of one of the applicants' minibus, and the break-in into another applicant's laptop during her absence from the hotel?

Group 4: Has there been a violation of Articles 8 or 10 of the Convention due to the rejection of the applicants' requests to access information in the State archives about the fates of relatives imprisoned during the Soviet era, or about the victims of the Great Terror, for research purposes?

Group 5: Has there been a violation of Article 10 of the Convention on account of the prosecution of social media platforms for failing to take down the information which the Russian authorities deemed unlawful or to restore access to the information which breached the platforms' terms of use?
